#### **ASSITANCE LEAGUE OF VENTURA COUNTY (ALVC)**

ALVC is a nonprofit volunteer organization dedicated to the enrichment of the lives of children in Ventura County and the betterment of their future. In collaboration with Homes with Heart VC, the Assistance League provides gently used clothing, shoes and emergency support to Resource Families, "fragile" families and youth who have aged out of care through the HWH Care Closet. ALVC also runs The Bargain Box which is an upscale resale shop staffed and managed entirely by volunteer members. The store provides a continuing source of income for the chapter's philanthropic programs including the HWH Care closet and emergency assistance to CFS children, youth and families. #### iFoster Online Resource Portal

Youth in care, resource families, relative caregivers, and professionals working with any of those groups can access local resources and retail discounts. Resources also include free online counseling with a life coach, tutoring, free cell phones, discounted laptop computers, and discounted orthodontics.

AmeriCorps Program: Youth 18-26 years old can earn \$ and scholarships for college while helping other youth in care, no work experience required, minimum 60hrs per month in Ventura, LA county, Sacramento and the Bay area.

### **CASA of Ventura County**





Court Appointed Special Advocates (CASA) of Ventura County believes that every court-dependent abused or neglected child should be safe, have permanence and the opportunity to thrive, and have a strong, compassionate volunteer advocate. CASA recruits, screens, trains, supervises and support volunteers who advocate for children in care appointed by the Juvenile Dependency Court to the CASA program. The CASA Advocate is the person who can be counted on to respond to those most basic needs for reassurance, guidance, comfort, representation and advocacy in times of extreme uncertainty, and is the one constant, positive presence in the child's life until a permanent placement can be secured. #### RaisingHOPE Mentorship Program

RaisingHOPE's mentoring program connects trainer, background checked mentors with youth to give a reliable, stable caring adult connection for a lifetime. RaisingHOPE serves all youth in care, but primary focus is on the older youth (pre-teens, teens and non-minor dependents), and also take referrals for youth up to age 25 that are still need of support. All mentors are screened, trained and evaluated. This program is voluntary for all youth, and youth are screened to ensure the maximum effectiveness of the relationship. Once approved, mentors meet with mentees 2 times per month minimum to build relationships and visit within the community. #### **Channel Islands Social Services**

Approved Resource Families (RFA) are eligible for up to 12 hours of FREE respite care each month. Families caring for Ventura County dependent children ages 16 or under, or a child with special needs, are automatically eligible and can contact www.islandsocialservices.org directly at 805-384-0983 to register. If your family is caring for children over 16 or requires more than 12 hours, social workers can request an exception to the basic eligibility. These cases will be reviewed for need, natural support system, and plan for when the short-term exception ends. FFA certified homes are eligible for respite and should contact their agency for more information.

## **Child Care/Child Development**

#### Catalyst Kids (formerly Child Development Centers)

Catalyst Kids operates early care and education that serve children birth through twelve years of age. They offer a variety of infant, preschool and school age programs. They work with school districts to provide before and after school programs, including homework assistance and kindergarten readiness programs to families including preschool programs in Oxnard, Fillmore, Ventura, Thousand Oaks, & Port Hueneme. Children in care are often eligible for priority assignment into a program and subsidized care. #### **Child Development Resources**

CDR administers a range of childcare programs and provides referrals to community childcare providers. Children in care may receive priority assignment from the wait list and subsidies with verification from their social worker that the child is a court dependent minor. In order to apply, resource parents should complete the following steps:

- 1) Complete the Centralized Eligibility List Application, which can be downloaded HERE.
- 2) Homes with Heart VC will provide a letter of verification of the child's dependent status. Please email strengtheningvcfamilies@ventura.org to request this verification.
- 3) Submit application and letter directly to CDR by email: info@localhost or in person at 221 E. Ventura Blvd, Oxnard 93036.

## **Children's Home Society (CHS)**

Children's Home Society provides a variety of services to children and families in California and nationwide — working to improve their quality of life by offering vital informational, educational, and resource services, which include Early Learning and Education Programs, and Family Resource Services. Children in care are often eligible for priority assignment into a program and subsidized care. To access services for childcare, resource families will need to complete and submit an application. They can do this online at CHS-CA.org, go in to the office at 1801 Solar Drive, Ste.195 in Oxnard or call 805-437-1910 and request an application be mailed. Services provided are based off the child's income, and resource families will need to have a referral letter from their Case Worker to add to the application.





#### **Easterseals Child Development Center**

The Easterseals Child Development Center serves children 0 to 3 years of age through their free Early Head Start and Home Base Visitor Programs to income qualifying families. The Easterseals California State Preschool Program is a free to low monthly fee full-day preschool program focusing on preparing young children for Kindergarten success through indoor and outdoor classrooms. #### First 5 Neighborhoods for Learning (NfL)

We are in your neighborhood! Throughout Ventura County, the First 5 Neighborhoods for Learning, Powered by Interface (NfLs) are helping families raise children who are healthy, nurtured, and prepared for kindergarten. The NfLs offer **PACT** (Parent and Child Together) classes and resources for families. Families can access **screenings**, **referrals**, **parent education**, and more in familiar, high-quality settings. PACT (Parent and Child Together) Classes do not serve as a therapeutic intervention. However, it provides opportunities and a venue to strengthen the parent and child relationship, build social connections and provide a high quality early learning environment for you and your child. First 5 Ventura County has multiple NfL sites that offer parenting support, early literacy activities, and case management for families with children that are 0-5. FYSCP works in collaboration with liaisons in each district in the county to ensure that the educational, physical, social and emotional needs of youth in care are identified, to determine gaps in educational and social support services and provide those services, directly or through referrals to collaborative partners. The program also seeks to facilitate the completion and timely transfer of school records, improve students' academic achievement, reduce truancy, dropout rates and delinquent behavior, and provide advocacy to promote the best interest of youths in care throughout the county. #### **ILP Funding Reimbursement Requests for Youth Ages 16-21**

Resource available to provide a range of financial supports to Ventura County dependent youth and their families. Families can apply for reimbursement for expenses related to extracurricular activities, education (high school, college/vocational), transportation, employment and housing expenses. Some categories are limited for the fiscal year, while others may be a one-time only reimbursement. Requests for reimbursement will only be considered within 90 days of original purchase and reimbursement checks may take up to 60 days to process. #### **California Chafee Grant for Youth in Care**

May qualify for up to \$5,000 a year to help pay for college, childcare, transportation and rent while you are in school. You can use your Chafee Grant at any eligible California college or university or career or technical school, as well as schools in other states. Must be a current or former youth in care and not have reached your 22nd birthday as of July of the award year. The court must have established your dependency when you were between the ages of 16 and 18. The California Department of Social Services (CDSS) will verify your eligibility status. Must submit FAFSA or CA Dream Act Application and Chafee Grant Application (for first time applicants). Visit: www.chafee.csac.ca.gov.





#### **TEACh Scholarship Fund**

This scholarship is for graduating high school seniors and graduates under the age of 25 who are or have been in care or a group home in Ventura County, California. To qualify for this scholarship, applicants must be current or emancipated youth in care who will attend or who are currently attending a community college, trade/technical school, or four-year college/university. ## **Homeless Services/Food Pantries**

#### **Project Understanding**

Project Understanding guides and supports clients to achieve their highest attainable level of independence. They monitor progress, as well as provide a system of accountability. They strive to prevent homelessness for clients and move homeless clients out of homelessness as soon as possible. The intake process at the **First Step Center** is the first step for individuals and families to begin identifying and solving problems in their lives. Intake Specialists assist clients with realistic objectives, resources and referrals. Some of the most common referrals offered are DMV reduced-fee vouchers,





utility payment assistance through Community Action, referrals to our H2H (Homeless 2 Home) program, and Rental Assistance through H2H to prevent homelessness. Representatives from outside programs visit once a month to meet with clients and start the application process. - **Food Pantry**: Provides groceries twice a month to registered families. To register stop by Mon, Wed or Frid from 9am-12pm. Picture ID is required for registration.
- Homeless to Home (H2H): For assistance call (805)231-2299 Mon-Frid between 9am-4pm.
   Requirements Proof of Income: Last 2 check stubs, SSI/SSA/Disability award letter or bank statement if direct deposit, food stamps, and/or unemployment stubs.
   Proof of Address: Rental agreement; if renting a room, letter from landlord.
   Proof of Dependents/Custody: Rental agreement (if listed on it), legal paperwork and awarding custody. If homeless: ID and mailing address
- **SHORE at the WAV:** Supportive Housing Opportunities in a Residential Environment. The goal of this program is to assist those who desire to end their homelessness with case management of previously homeless families and individuals in permanent, supportive housing apartments subsidized by Section 8 funds.

### **Harbor House (Conejo Valley only)**

Harbor House can refer clients based on their needs. Using the Homeless Management Information System (HMIS), they can access countywide resources to help with housing, emergency shelter, meals, employment, legal, medical and psychological services. **Case Managers** assist those who are homeless or on the edge of homelessness in becoming more self-sufficient. They help each person create attainable goals and walk alongside them, help with life skills like problem solving, money management and conflict resolution. **Gas & Electricity Assistance**: Assists all Ventura county residents with gas (GAF) and electricity (EAF) bills. Southern California Edison assistance is provided once in a 12-month period and The Gas Co assistance is provided once in a winter program period.





Certain income criteria applies. Visit harborhouseto.org/programs to download the Utility Assistance Program instructions, GAF and EAF applications.

- **Showers**: Hot showers are available every Thursday from 3:30-5:30pm at Holy Trinity Lutheran Church along with the daily meal/lunch program, sign up required.
- Laundry: Wednesdays from 2-4pm is Harbor House laundry day at Launderland located on 363 E. Avenida de Los Arboles, Thousand Oaks. Funds and detergent provided (two loads maximum per family).
- Rental Assistance: Emergency rental assistance for eviction prevention serves low-income families and individuals in the Conejo Valley. Eligibility is based on a set criteria and is determined through intake; documentation may be required.
- Adopt a family: Harbor House signs up families in the late early fall to be adopted for the holidays. In the past year over 400 families signed up which equates to between over 1100 children. Gifts are distributed in December.
- Other Assistance: Harbor House provides gas and bus vouchers to help in getting to work, school or doctor appointments.

#### **SPIRIT of Santa Paula**

SPIRIT of Santa Paula is a non-profit organization that collaborates with local and national agencies and organizations to offer a wide range of services from assisting with rental assistance, utility payments and advocacy in Homeless Court, counseling at their Resource Center for people who are homeless, hungry and lonely. They are ServSafe food certified and serve up to 600 hot meals each week. They are adept at food rescue, food pantry services, USDA food distribution and counseling. They provide support to parents with at-risk kids, sponsored outreach programs for kids in the park, the Police Clergy Council and 12-step efforts. They are located at 1498 E. Harvard Blvd, Santa Paula (805)229-7750.

  Santa Paula. Fridays from 9am to noon. Supports basic hygiene and connects homeless
  individuals with services helping their long-term stability including mental health, alcohol & drug
  programs and TB test appointments.
- A Little Laundry Every Friday from 7:30am-9:00am. Limit \$15 per person. HMIS ID required and must be homeless.
- Emergency Food Boxes By appointment only (805)340-5025.
- Food Pantry Wednesdays 4:30pm-5:30pm at 121 N. Davis Street, (805)340-5025.
- Food Rescue- In collaboration with the State of California CalRecycle Program & Waste Free
  Ventura County connects with commercial food service organizations who throw away food
  every day. If you have a connection with any food service organization such as school cafeterias,
  restaurants, catering services, food distributors and grocery stores refer them to SPIRIT. They
  have commercial refrigerators, freezers, trucks and know how to handle food safely.
